

Terms and Conditions for Training and Professional Development

1. Introduction

Welcome to Rob Smith Psychotherapy ('Organisation', 'I', 'Me', 'My'). These Terms and Conditions ("Terms") govern your use of my website and your purchase of digital products, including training sessions, workshops and related materials ("Products"). By purchasing these Products or using this website, you agree to be bound by these Terms. If you do not agree to these Terms, please do not use this website or purchase any of my products.

2. Eligibility

You must be at least 18 years of age to use my website and purchase Products. By placing an order, you confirm the following:

- 1. That you are at least 18 years of age
- 2. You are legally capable of entering into binding contracts
- 3. All information that you provide if materially true and accurate at all times and not misleading in any way

3. Description of Products

It is your responsibility to ensure the Product is suitable for your needs before purchasing.

4. Ordering and Payment

4.1 Placing an Order

4.2 Payment

Payment must be made in full at the time of purchase. I accept payments via the methods displayed on my website. All prices are inclusive of VAT (if applicable). Prices may change at any time, but changes will not affect orders that have already been completed.

4.3 Currency

All transactions will be processed in GBP (£), unless otherwise stated.

5. Delivery of Digital Products

5.1 Digital Download

After successful payment, you will be able to download the product from the 'Thank You' page and will also receive a confirmation email with a link to download the purchased Product. 5.2 Access Period

The download link will remain active for 30 days from the purchase of the product. It is your responsibility to download and store the product. I recommend saving a backup copy.

5.3. Download Limits

Each purchase entitles you to personal, non-commercial use of the Product. You will be able to download the content for 30 days from the date of purchase. Sharing, distributing, or making the Product publicly available is prohibited.

6. Consumer Rights

6.1 Right to Cancel

Under the Consumer Contracts (Information, Cancellations and Additional Charges) Regulations 2013, digital content (such as downloads) is exempt from the usual 14-day right to cancel **once you begin the download** or access the content. By purchasing and downloading our Products, you acknowledge that your right to cancel the contract ends once the download begins.

6.2 Refunds
